

## Governors Register of Interests

Governors and trustees have a legal duty to act only in the best interests of their schools. Where a situation arises in which they cannot do this due to a personal interest they have, steps are taken to identify, prevent and record the conflict. This ensures governors or trustees are acting in the best interests of the school.

Declaring your conflicts of interest is a legal requirement within the School Governance (Roles, Procedures and Allowances) (England) Regulations 2013

Governors must declare any conflict of interest/loyalty, business or personal that relates directly or indirectly, to themselves or any relation in any contract, proposed contract or other matter when present at a meeting at the school where such contract or matter comes under consideration. Governors must withdraw from any meeting during the discussion of such contract or matter and must not vote in respect of it.

Signed annual declarations of these interests are made by all governors of Camestone Lower School. Oral declarations are made at each meeting where a conflict may occur.
